CALL TO ORDER:

The meeting of the Board of Supervisors was called to order by Chairman Jeff Priddy at 7:00 PM at the Municipal Building. Members present were Jeff Priddy, Gene Lammey, Bob Newlin and Secretary/Treasurer Wendy Dettrey.

Motion to approve changing the speed limit on Upper Valley Road to 25 mph and to have the Roadmaster gather information on installing speed bumps was made by Gene Lammey and seconded by Bob Newlin.

Motion to approve the bid advertisement for stone was made by Bob Newlin and seconded by Gene Lammey.

The Stormwater Ordinance update was tabled.

The Adaptive Re-Use draft will be reviewed by the Planning Commission at their next meeting.

NEW BUSINESS:

Motion to approve the Lancaster County Drug Task Force contribution in the amount of \$3,536.00 was made by Jeff Priddy and seconded by Bob Newlin.

Motion to approve the agreement between the Township and Authority for services was made by Bob Newlin and seconded by Gene Lammey.

Lancaster EMS sent a thank you letter to the Township for the contribution made in the amount of \$5,000.

There was a discussion on the Enola Trail project. The proposed start date is the year 2025 with completion in the year 2026.
