April 2, 2024, at 7:00 pm**

CALL TO ORDER:

Motion to approve the purchase of a backhoe was made by Bob Newlin and seconded by Gene Lammey.

NEW BUSINESS:

Motion to approve the bid for crushed aggregate stone was made by Jeff Priddy and seconded by Bob Newlin.

Motion to approve the bid for equipment rental was made by Gene Lammey and seconded by Bob Newlin.

Motion to approve the shared expense of the worker's compensation policy for Christiana Ambulance with Christian Boro and Atglen Boro was made by Bob Newlin and seconded by Gene Lammey.

Discussion on purchasing a credit card machine was tabled.

There was discussion on the Municipal Records Retention policy and disposing of old documents.
